#### **What A Finish**

It appears the 2012-13 school year was especially busy for all. You are to be commended for helping our students to become more successful and at the same time, working to incorporate all of the initiatives being implemented into schools and education. As you prepare for graduations, retirements and the closing of the school year, we continue to be on "high alert" because the Illinois Legislature still has an opportunity to "mess with" our pensions. As I write this. the Senate has passed SB2404 sponsored by Senate President Cullerton, the We Are One Coalition agreed upon bill. The bipartisan vote was 40 YEAS and 16 NAYS. The House Bill Amendment to SB1 sponsored by Speaker Madigan passed the House on May 2 but has not yet been taken up in the Senate. While neither bill is preferable. the proposed House bill will have a much more detrimental effect on both our active and retired members. If you happened to have missed this flurry of activity in the legislature, please go to the IFT website, www.ift-aft.org in the upper right hand corner labeled Pension Watch and get all of the details.

Yesterday I attended a reception at the high school where I taught for nearly 35 years. There were active and retired teachers and support staff, as well as administrators present, many of whom I had worked with during my tenure. I was struck by the fact that I received many "thank you's" for all of the work I had done in order to help secure our pensions. While I greatly appreciate their kind words, I want to be clear that it was in fact not only me, but *they* who had taken the time to reach out and talk to their local legislators. It is our collective

voice that resonates in the Springfield Capitol, not just "a" voice. And that must not stop. We still have more to do before the end of May.

We have heard repeatedly that Illinois funding, especially of our pensions, is in the worst shape ever. The We Are One pension bill that we worked so hard to pass is one of shared sacrifice. Over 700,000 active and retired teachers. nurses, university educators, police, fire fighters and state workers have and will continue to give back to help the state's funding crisis. The dollar amount is staggering, as much as \$45 billion over 30 years. Is it possible that large corporations, companies and businesses that reap the rewards of doing business in Illinois will step up as Illinois workers have done to offer their shared sacrifice in helping to solve the state's fiscal crisis? Sounds fair and equitable, right? We'll see how that goes!

#### What a start!

We look forward to celebrating with you this fall the 75th anniversary of Local 571. On May 18, 1938, ten teachers with great foresight signed the charter and became Local 571, West Suburban Teachers Union, IFT-AFT/AFL-CIO. We have grown to over 5500+ members who work in the public schools in western Cook and eastern DuPage Counties. The 75<sup>th</sup> Anniversary Planning Committee is assembled and working to create a memorable experience. Look for your invitation to arrive as the next school year begins.

### **Getting The Common Core Right**

On April 30, AFT President Randi Weingarten, while speaking to the Association for a Better New York, called for a moratorium to highstakes testing of the Common Core State

Standards until they are field-tested, revised, and aligned with curriculum, professional development, and instructional materials. She compared punishing teachers for student performance on Common Core assessments to "doctors being expected to perform a new medical pro-

cedure without being trained or provided with the necessary instruments."

A major piece of this alignment is the adoption of instructional materials that truly support the Common Core.

In English language arts, we now have a set of publishers' criteria that has been developed by the Common Core authors and revised with the collaboration of stakeholders including teachers and researchers. These key criteria for English language arts and literacy materials developed out of the standards coordinated by the National Governors Association Center for Best Practices and the Council of Chief State School Officers.

How do we recognize which materials to adopt for the Common Core in English language arts?

Early literacy materials must systematically use all the research-based elements of effective beginning reading instruction. These are concepts of print, phonological awareness, phonics, vocabulary development, syntax and fluency. These elements must be used to support comprehension right from the start.

Materials for the early grades should also have a strong focus on fluency. Good programs contain a variety of specific fluency-building techniques such as choral reading, repeated oral reading, and monitored partner reading. Also, a strong focus on academic vocabulary is needed to address the extreme variances in vocabulary

knowledge among students.

Because the listening comprehension of young readers surpasses their reading ability, there must also be coordinated and high-quality read-alouds for the teacher.

Materials for all grade levels should meet key guidelines for text selection. An equal balance between literary and informational texts is a significant shift. Also, only high-quality selections that are well-written and worth reading and re-reading should be included. Selections should also be accompanied by specific Close Reading lessons across genres and text-lengths.

How do we recognize which materials to adopt for the Common Core...?

Looking at the questions and tasks in an instructional series is also a useful way to see if they fit the Common Core. Common Core questions are text specific and avoid being generic. Al-

though there is a place in instruction for general questions, Common Core materials will limit their use and not rely on "cookie-cutter" questions, such as finding the main idea and three supporting details, which could apply to any text. Good questions also integrate what the students have just read to what they have read previously.

Ample practice writing to sources is another important component, as is instruction in grammar and language conventions that match those given by grade level in the Common Core.

Randi Weingarten pointed out that the Common Core will either "lead to a revolution in teaching and learning, or end up in the dustbin of abandoned reforms." Adopting excellent materials is a large part of getting this right.
