

Eleventh Annual Local 571 Legislative Breakfast By Bonnie Saracco and Andrew Bendelow

Local 571 President Jane Russell welcomed a packed house to our 2016 Legislative Breakfast on September 24th at the Hilton Chicago Oak Brook Resort and Conference



571 President Jane Russell reminded members and guests, as well as their families, friends, and co-workers, to VOTE up and down the ballot in this very important presidential election.

Center. The morning began with a video message from Congresswoman Tammy Duckworth, who is a candidate for the U.S. Senate. She talked about how important public education has been in her life and how she is inspired by us. She promised to be a strong advocate for our concerns, stating that she would "tell our story because there is no more important investment than investing in our children."

We then heard from City of Chicago Clerk Susana Mendoza, who is running for state comptroller. She told about being raised as the child of Mexican immigrants, and said that she wants to control the state's checkbook so that

"someone with a moral compass can decide where funds go." She called herself an "independent truth teller who will stand up for the most vulnerable in the state," in contrast to the current state comptroller who was appointed by Governor Rauner and has done things such as cutting state funding to help those with autism. She also recommended early voting.

Brandon Johnson of the Chicago Teachers' Union talked about CTU's fight against Mayor Rahm Emanuel's anti-public school policies. He said that two billion dollars have been lost during Emanuel's term, resulting in cuts in student services, rises in class size, and layoffs. He added that Chicago has

millions of dollars in TIF money that is being withheld for special interests, and that these funds could solve the current CPS funding crisis.

Cynthia Riseman, IFT Director of Political Activities,

presented an overview of the current political situation in Illinois, outlining the most significant races. IFT's priority is to support the candidates who will fight against Governor Rauner's "turnaround agenda." The good news is that so far his agenda has been stopped by the courts and the General Assembly. Then she asked questions of the legislators who were pre-



sent. The following are some of their responses:

Representative Chris Welch, 7th District, said that he was a product of public schools and is no fan of charter

schools. He supports the NAACP's call for a moratorium on new charter schools. He wants to weaken the powers of the state charter commission and to strengthen local school boards. He said it would be "absolutely ridiculous to lift the current cap on charters."

leaning now toward Senator Lightford's proposal for reforming Illinois school funding because there is too much inequality between municipalities. He also stressed that we are wasting resources if we do not address the social and emotional needs of students.

Senator Laura Murphy, 28th District, said that excessive testing hurts students by limiting teacher autonomy,

and that it also wastes too much time. She stated that the Tier 2 pension system is grossly unfair because members are paying in more than they will get back. She said that everyone needs to be involved to negotiate a better bill for Tier 2.

Senator Don Harmon, 39th District, said that we need a

budget that adequately funds schools, rather than the "bare bones" six month budget that we have now. He said that the current budget is just "emergency provisioning." He derided the governor's efforts to take away our right to collective bargaining, apologized for all the stress caused to retirees by pension threats, and said that we need to keep our communities via-

ble and vibrant with great public schools. He also said that we need to "hit the pause button" on charters, and that Illinois needs a fair, graduated income tax.

As always, our raffle successfully raised funds for our COPE and scholarship programs. We are already looking forward to our twelfth annual Legislative Breakfast next year.

Retiree Corner

Retiree Council Luncheon—The annual Local 571 Retirees Council luncheon in Westmont on September 29, 2016, hosted 65 attendees including 14 newly retired members. The business meeting was chaired by President Phyllis Meade and Secretary Treasurer Dee Pospishil. There was an opportunity to catch up with old friends and make new ones before the program which featured IFT Political Activities Director, Cynthia Riseman. She provided a Power-Point presentation on the Illinois 2016 political landscape, citing IFT priorities in statewide races as well as the legislative races. Cynthia reminded everyone to support AND vote for the list of IFT endorsed candidates that can be found at www.ift-aft.org/vote.

Senior Power Lunch—On October 5, the IARA held its annual 2016 Senior Power Lunch in Chicago. The Illinois Alliance for Retired Americans, IARA, is a statewide organization with 145,000 members working together to make their voices heard in the laws, policies, politics and institutions that shape our lives. Retired members from unions such as AFSCME, IFT, SEIU Healthcare, UAW Re-

gion 4, CTU, United Steelworkers (SOAR), Workers United and community organizations and their guests rounded out the crowd of nearly 120.

Congresswoman Jan Schakowsky talked about her history with the IARA going back to its beginnings. Congresswoman Schakowsky also introduced one of her Congressional colleagues, Congresswoman Robin Kelly, who described her efforts in Congress most recently lobbying for a

bill about senior dental health. Congresswoman Kelly has a 100% voting record with the Alliance for Retired Americans. The program would not be complete without an outstanding speaker who always excites the crowd, William McNary, Co-Director of Citizen Action/ Illinois.

Worksite Leader Training at WSTU

- Political, Legislative and Community Engagement—reviews the Union's policy making and endorsement process

Worksite leader Training continues to be offered at other locations and will be offered again in Westmont in the spring. Watch for more information in future newsletters.






