(We) Will Survive

The title is a paraphrase of the 1978 hit song by Gloria Gaynor, "I Will Survive." The lyrics to the song begin with "At first I was afraid, I was



petrified. But then I spent so many nights thinking how you did me wrong. And I grew strong." The lyrics describe what has occurred this past year within our Union. As the 2017-18 school year comes to an end, we await what will be a momentous decision to public sector unions by the U.S. Supreme Court, *Janus v. AFSCME*. The decision will change our Union. In fact, the change has already begun.

We as members work with the boards of education and administrations to collectively

bargain for our wages, benefits and working conditions. We are fortunate in Illinois, a non-right-to-work state to be able to negotiate the first and successor agreements. This is not a right in many other states which are right-to-work (for less). For example, a group of Union teachers from AFT Austin, Texas, presented several workshops to IFT Local members discussing and sharing their seven-year development of Student Learning Objectives (SLOs) used to evaluate student growth. Based on the AFT Austin teachers' knowledge and expertise, we then began developing SLOs for use in our classrooms. During their workshops, the AFT Austin members often referred to "collective begging" which is their way of asking "permission" of their employers to attain adequate benefits and working conditions. This was a reminder to us, we need to work every day to maintain all the rights and benefits we currently enjoy.

This past school year, we asked our members and other co-workers who are designated fair share to sign new membership cards. By the time this final newsletter of the year is printed, the West Suburban Teachers Union which includes all the members of your Council, will be nearly 5,100 members strong. In fact, the "recarding" is nearly 95% complete. Individually we recognize that to be a Union, our strength lies in numbers. A strong Union membership will insure that your Union can continue to represent all members of the bargaining unit. There are many benefits to Union membership far beyond what is in your Union contract. Working Americans can thank the labor movement for many workers' rights.

Special Circumstances When Talking to Children about School Shootings By Bonnie Saracco

We know that the guidelines for talking with children about school shootings include being factual, developmentally-appropriate, and a good listener. But it is especially challenging to have these conversations with a child who has special needs, or who is having difficulty coping emotionally with the news.

If a child has developmental delays, we need to gear these conversations to his or her developmental, rather than chronological age. This often means providing a more limited amount of information and avoiding graphic details. Adolescents with developmental delays still need reassurance that, although it is normal to feel anxious, the probability of personally being in a school shooting is very low, and that responsible adults are working to keep them safe. Parents and teachers of children with autism spectrum disorders should employ the same techniques that keep the child calm in other circumstances.

There are classic signs which show that a child is not coping well with news of shootings, and that professional support is needed. They include sleep problems such as unusual difficulty falling asleep, staying asleep, and waking up. They also include physical problems such as headaches, stomachaches, chronic fatigue, and changes in eating habits. There are the emotional symptoms of regressive behaviors such as acting unusually immature, sensitive, demanding, and experiencing difficulty separating from parents. Teens can suffer overwhelming depression and engage in new or increased abuse of alcohol and other substances.



Children who have a personal connection to the shooting, or who have experienced prior trauma, are at increased risk for these problems, and need to be closely observed. They need professional help sooner rather than later. In addition to school and community resources, the American Psychological Association can help us find referrals with its Psychologist Locator, https://locator.apa.org.

Our hyper-connected, partisan world makes it difficult to control the messages that are bombarding our children. We need to counteract the stereotypes in the news, as children quickly generalize. Perhaps most challenging of all, we need to unceasingly fight bullying and teasing.

Finally, we should take good care of ourselves. When added to all of our other responsibilities, the task of helping children cope with news of school shootings can be overwhelming. In their publication *How to Talk to Children about Difficult News*, the American Psychological Association urges us to "Turn off the news, take a break, engage in physical activity, and do something that will lift your spirits and those of your family."

Cathy's Corner





Our suggested read for this issue is a memoir from Tara Westover called *Educated*. In this age of standardized testing and assessments, it was

refreshing and interesting to read a story about a young girl who was kept out of school, leaves her survivalist family and goes on to earn a PhD from Cambridge University. We watch this woman's narrow world open through education. Westover takes us on a journey from a minimalist lifestyle, abuse, and isolation to a new academic life and success. She was the youngest of seven children who grew up on a beautiful mountain in Idaho and was not allowed to go to school or to a doctor.

With the influence of her older brother, she tried to educate herself. At the age of 17,

she walked into a classroom for the first time, and found herself on the path of education that took her away from her family. She learned about world events like the Civil Rights Movement and the Holocaust for the first time. Now she was able to see her life through new eyes. In the end, she struggles with the question, "What do you do when you find that loyalty to your



family is in conflict with loyalty to yourself?"

AFT Severs Relationship with Wells Fargo over Guns

WASHINGTON—American Federation of Teachers President Randi Weingarten announced today that the union would cut ties with Wells Fargo, after CEO Tim Sloan failed to follow up on meeting with the union to discuss the bank's relationship with the National Rifle Association and gun manufacturers.

Earlier this month, the AFT released correspondence from Weingarten to Sloan outlining the union's concerns about Wells Fargo's connections with the NRA as well as its intention to stop offering Wells Fargo mortgages if Wells Fargo continues being the NRA banker.

The Wells Fargo mortgage program is part of the Union Privilege program, and approximately 1,600 AFT members have opted for these mortgages annually. More than 20,000 AFT members currently hold mortgages through the program. Today, the AFT will officially remove the bank from its list of approved lenders, sending a letter to each of its state federation leaders alerting them of the change. The AFT will urge other Union Privilege members to follow suit.

"Gun violence is an epidemic, but Tim Sloan won't even engage in a conversation about mitigating it, much less take any real steps. We took him up on his offer to meet with us, then he went radio silent. So if Wells Fargo won't value children and teachers above guns, we won't do business with Wells Fargo," Weingarten said. "It can be the bank for America's teachers, or it can be the bank for the NRA and gun manufacturers. But, given the NRA's refusal to even help mitigate gun violence, Wells Fargo can't be both. Other companies, like Bank of America, BlackRock and Vanguard, have stepped up and engaged in meaningful conversations about what responsible relationships with gun companies look like, but Wells Fargo won't. In fact, when we tried to schedule a meeting to discuss it, its friends at NRATV started launching vile attacks on teachers and personal attacks against me.

"We're ending this relationship because we have a responsibility to our members and their students, who face potential gun violence every day. Gun violence is a public health epidemic, and in order to help stop it, we'll stop the flow of resources to the companies that manufacture these weapons that have caused so much civilian carnage and death."
