### SB1 on Becoming SB 1947—School Funding at a High Price

For several years, lawmakers, especially Senator Andy Manar from downstate Bunker Hill, worked tirelessly on the new education funding reform bill now known as SB1. The IFT Department of Political Activities carefully watched the formation of the bill which is an evidence-



based model for school funding. During that time, the IFT assessed whether or not school districts would in fact gain the needed funds to educate their students. Through several iterations of the bill, the IFT was not in support because some of the school districts gained funding while others lost it. One of the main goals in writing the bill was to make sure that no school district would lose funding. This was not easy to accomplish.

Beginning on February 10, 2017, when SB1 was first filed in the Senate, it proceeded through the legislative process, passed by both houses and was sent to the governor who made an amendatory veto of the bill with considerable changes. The new bill was filed as SB1947. Although the Senate was able to override the veto of SB1, the House was not able to do so. The House then considered SB1947 which initially did not pass, but with an "agreement" by the four legislative leaders, the House reconsidered SB1947 and it passed on August 28, 2017. The Senate followed with passage the next day. The Governor signed SB1947 into law on August 31, 2017.

Although SB1, which was strongly supported by the IFT, remains largely intact as SB1947, there are at least two objectionable components of the bill. A voucher-style program was created to allow businesses and wealthy individuals to claim a tax credit for donations to private school scholarship funds. This program will cost over \$75 million over the next five years, robbing public schools of students and resources. The second component is mandate relief. Specifically, the 5-day PE requirement can be reduced to no fewer than three times per week and allows PE exemptions for students in grades 7—12. Currently these PE exemptions were limited to juniors and seniors in extracurricular activities. The process to change the number of days of PE offered in the district much first have a public hearing and then school board approval.

## Watching Our Backs By Bonnie Saracco

Sadly, AFT found it necessary at last summer's 2017 TEACH conference in Washington, D.C. to warn attendees about **right-wing operatives** who were there to conduct a smear campaign. We were directed to be careful at all times. This included in general sessions, at presentations, and when socializing.

D.C., and federal law provide that individuals can tape others without their consent. Because Illinois law can



be confusing and murky on this subject, we all need to be aware of the precautions needed to protect ourselves when attending union conferences and other events. Also, our opponents have shown little respect for law, having been arrested for illegal tactics including breaking into the office of a U.S. Senator.

We were told to guard our credentials and never leave them unattended. Stolen badges will get these people where they want to go. We were warned not to become their targets by wearing our badges

outside the conference, to notify an AFT staff member if we suspected we were being taped, and to walk away from uncomfortable situations.

What are uncomfortable situations? Instincts should be trusted. **Our opponents use false identities and produce fake educational service organizations to gain entrance to union events**. They steer conversations into potentially-hazardous areas such as student discipline and relationships with parents. They want to talk to us about our students, classrooms, and our feelings about the union.

Also, knowing that teachers can be kind and empathetic, they try to trap us into agreeing with them. It is important for us to always say what we really believe, rather than agreeing to avoid confrontations. Even if our statements are not recorded on tape, they can be quoted.

One of their most aggressive moves is the **ambush interview**. If confronted in this way, we were to refer them to the AFT Press Office rather than saying "no comment," which can be twisted to sound incriminating.

While we never want to stifle our voices and become intimidated in the fight for what we believe, these deceivers have created a situation in which the safeguarding behaviors which might have seemed paranoid in the past have become mandatory today.

Additionally, school districts will be permitted to hire outside parties to provide drivers' education services without seeking a waiver from the Illinois State Board of Education.

Other organizations joined with the IFT to oppose SB1947 including the Illinois Education Association, School Management Alliance, League of Women Voters and the American Civil Liberties Union. The IFT strongly urged legislators to override the Governor's veto of SB1 or pass a compromise bill that did not contain tax credits and mandate relief.

Dan Montgomery, IFT President, in his August 30, 2017 statement about SB1947 passage said, "The agreement comes at a high price. But for the first time since 1997, Illinois will begin to move away from its

archaic, inequitable school funding system and towards one that ensures every district in the state will receive appropriate support." Montgomery sums up saying, "But it's clearer than ever that this Governor does not prioritize public schools, and we must fight for one who does in 2018."

As we continue to fight for our students and the public schools where we work, I wish you and your students a positive and successful 2017-18 school year.
