### Fair is Fair! (Part 2)

Hopefully you did your homework to determine how the Illinois Fair Tax will affect your family by using the calculator, <a href="www2.illinois.gov/sites/gov/fairtax">www2.illinois.gov/sites/gov/fairtax</a>.



Why a Fair Tax? Illinois could cut middle-class taxes, balance the budget and grow the economy. Data from State and Local Tax Shares of Family Income (for non-elderly taxpayers) shows the top one percent of income earners pay 7.4 percent of their income in state and local taxes while the bottom 20 percent of earners pay 14.4 percent of their income. The percent of Illinois taxpayers whose net income is \$100,000 or less is over 86%.

Like the federal government and 33 other states, income is taxed in steps or brackets. As this is being written, the proposed marginal (graduated) rates for different incomes or brackets were passed out of the Illinois Senate (SB687) and sent to the Illinois House. Included is both property tax relief and child care credits. The Illinois House will most likely make some changes to what the Senate has proposed. Both houses need to pass the bill by 3/5 majority before it can be sent to the Governor. Assuming the Governor signs the bill, the proposed amendment will be on the November 2020 ballot changing the article in the Illinois Constitution from a flat tax to a graduated tax. Illinois voters must approve of the proposed constitutional change by a certain margin.

With the Governor's proposed plan, 97% of Illinois households will see tax relief in their income tax. Only those making over \$250,000 will pay over the current flat tax of 4.95%. Any income earners making over \$1,000,000 will pay the highest rate.

#### If not now, then when?

The state is desperate for funding to be able to pay its bills, estimated at \$3.4 billion in 2020. The only suggestion and what was done under a previous administration was to cut funding for social services, higher education and safety, which has proven to be disastrous for the welfare of Illinois citizens. All one needs to do is listen to the news or pick up a local paper to find examples of people, particularly those in poverty, who have suffered and continue to suffer as a result of services cut by lack of state funding.

#### Randi Weingarten's Speech to the National Press Club on Saving Our Profession

Teaching is in trouble. According to statistics reported by AFT, teachers and other school staff are quitting the profession at the rate of approximately 300,000 each year, two—thirds of them before retirement age. Between 2008 and 2015, enrollment in teacher education programs decreased 38%. Last year there was a teacher shortage in every state, totaling more than 110,000 vacancies. Over 100,000 classrooms in our country are now staffed by teachers without proper credentials. Every one of these situations hits students of color and students living in poverty the hardest.

We all know the answer we will get when we ask a newlyretired teacher how he or she feels about retirement. And for the first time in fifty years, the majority of parents in the United States do not want their children to become teachers. Teachers in focus groups typically report entering the profession with excitement only to soon become stressed and demoralized.

AFT President Randi Weingarten discussed this heartbreaking situation in her April 2019 speech to the National Press Club, giving its two main causes as our

country's disinvestment in its schools and the deprofessionalization of teaching.

Weingarten talked about the national disgrace of school disinvestment. Twenty-five states spend less on public education today than they did a decade ago. **Teachers eam 24% less than other college graduates, and often work at second and third jobs to support themselves and their families**. Last year saw several statewide teacher strikes. The American Society of Civil Engineers gave a grade of D+ to our public school buildings, citing schools with rats, toxic mold, hot classrooms in summer and cold classrooms in winter. A shameful example of this situation occurred when the water was turned off in several Detroit schools last year due to high levels of contaminants, including lead.

Weingarten also described how deprofessionalization is killing the soul of teaching." **Two of the biggest culprits are the testing obsession and its accompanying mountain of paperwork.** Also, many teachers report being micromanaged to the point of having to adhere to textbook publisher provided scripts, schedules, and even classroom decorations.

There are three goals that we need to focus on to negotiate and legislate our country out of this crisis. They are creating a culture of collaboration, maintaining proper teaching and learning conditions, and ensuring that teachers have true voice and agency.

A culture of collaboration requires building time into school schedules to enable teachers to observe and learn from one another, and to look at student work and plan together. We need to create proper teaching and learning environments by asking teachers, students, and parents what is needed and then acting on their answers.

Weingarten said that teachers will never have voice as long as they are required to "check their ideas, imagination, and initiative at the schoolhouse door." For example, the Metro Nashville Public Schools now forbids its teachers to use Donors Choose because school officials want to control the donations themselves. As Weingarten

pointed out, "The further away from the classroom, the more authority someone seems to have over teachers' work. This makes no sense."

#### If not this, then what?

Several budget "fixes" have been floated. Remember how the Illinois lottery was going to be used to fund schools? State government now has the least number of workers of any state having reduced its staffs considerably. Taxing services and increasing gas taxes to fund Illinois roadways continue to be discussed. Not one of these changes will provide the amount of sustained funding needed to operate the state nor pull the state out of its debt.

To be able to generate the funds needed, it is calculated that the current flat tax would have to increase from 4.95% to 5.95%. This would be a final resort if there is not a Fair Tax proposal. The Fair Tax proposal will generate more money for schools and public services if the wealthiest are asked to pay their fair share.
